TAXES

MOBOCES DOES NOT HAVE THE ABILITY TO LEVY TAX OF ANY KIND.

STATE AID

MOBOCES ADOPTS A BALANCED BUDGET

THE BOCES INITIAL BUDGET AND RATES ARE BASED ON THE ANTICIPATED DEMAND AND THE RESOURCES NECESSARY TO DELIVER THOSE SERVICES.



FUNDS RECEIVED BY MOBOCES THAT ARE NOT SPENT ARE RETURNED TO SCHOOLS

AT THE END OF EACH FISCAL YEAR REFUNDS ARE ISSUED AS A ONE-TIME REVENUE SOURCE AND USED BY DISTRICTS FOR DAILY OPERATIONS OR TO REDUCE THE TAX LEVY.



AUDITS

EVERY BOCES IS SUBJECT TO AN ANNUAL INDEPENDENT FINANCIAL AUDIT, MUST EMPLOY THE SERVICES OF AN INTERNAL AUDITOR, AND IS ALSO SUBJECT TO AUDITS BY THE OFFICE OF THE STATE COMPTROLLER.

PURCHASING

MOBOCES CANNOT PURCHASE MOST MATERIALS WITHOUT A QUOTE, BID, OR CONTRACT, ASSURING THE LOWEST COST FOR ALL MATERIALS IS ALL THAT IS EXPENDED.



STAFFING

MOBOCES PROGRAMS EMPLOY STAFF BASED ON ANNUAL DEMAND. WHEN THERE IS LESS DEMAND THAN ANTICIPATED, BOCES REDUCES STAFF. IF DEMAND IS HIGHER AND BOCES CAN DELIVER THOSE SERVICES WITH EXISTING STAFF, IT DOES, LOWERING THE COST FOR ALL DISTRICTS REQUESTING THAT SERVICE.
